### US to provide \$250,000 for IPR protection training

The US government will provide \$250,000 dollars to India for training in protection of Intellectual Property Rights and building IPR enforcement capacity with a focus on the Delhi and Bangalore High Courts. With a view to enhance efforts to combat transnational crime, promote the rule of law and the protection of IPR worldwide, the U state Department has approved nine new projects totaling three million dollars in anticrime funds, including one in India. Training assistance to India for \$250,000 to build up the IPR criminal enforcement capacity of India, with a focus on the New Delhi and Bangalore High courts has been allocated — A spokesman from the Office of the State Department said.

### Geographical Indication for Nilgiris Orthodox tea

Nilgiris Orthodox tea has been registered under Geographical Indications act 1999. The application was filed by the Tea Board to the Registrar, Geographical indications Registry, Chennai. The registration is the recognition of the orthodox tea's manufactured in the Nilgiris known for their unique layour attributable and specific to the geographical region of the Nilgiris. The registration will facilitate individual authorized users to handle 'geographical indications logo' acknowledging the concerned orthodox tea's place of origin and special characteristics.

### Surgeon got Patent for his innovative helmet

Dr. M.K. Kuruvilla, a surgeon from Kochi, got a patent for his innovative helmet which will protect the medulla oblongata and the upper end of the spinal cord of the two - wheeler riders, which is the common cause of instant deaths during accidents. The helmets in use now protect only the skull and limit the extend of head injuries. The new device can be made of the same material as the shell of a helmet. The neck piece can be fastened firmly. This allows free movement of the outer part along with the head. It will not slip out or tilt from the inner segment. The arrangement ensures free movement of the head to maintain the balance while riding. Dr. Kuruvilla said that the device can effectively prevent hyper — flexion and hyper — ex-tension at the occipital — atlas — axis complex and damage to the medulla oblongata and the spinal cord. The new helmet weights more than 100 grams than the normal helmets because of the incorporation of the safety feature.

### Geographical Indications for Chikankari

Bagging a Geographical Indication for chikankari is the first step that Lucknow has taken towards the promotion of the 400 – year old art. Lucknow got the GI for Chikankari in December 2008. Chikankari is actually a very complex and delicate form of embroidery that primarily uses muslin clothes. This kind of embroidery is only confined to the city of Lucknow. The term 'Chikankari' has originated from the Persian word Chikan that means muslin wrought with needlework. The government will now have to use it as a branding and marketing tool to promote chikankari in the national and international market. The government of Uttar Pradesh can now initiate legal actions against manufacturers producing Chikan anywhere outside Lucknow. The GI certification will promote genuine Chikankari as the community which is producing Chikan in Lucknow, has got the exclusive rights to manufacture and market it. The GI will not only promote Lucknow commercially but also culturally. Chikankari is the second region – specific product from UP to get a GI after 'Surkha' from Allahabad.

### Kenyan cloud over India's pharma exports to Africa

Even as India is working hard to allay the doubt of African countries on the quality and safety of medicines supplied by its domestic countries, Kenya, the third biggest African market for Indian medicines, is planning a new legislation against "counterfeiting" that could seriously jeopardize India's medicine exports to Kenya.

The Anti – counterfeit bill, 2008, placed before the Kenyan Parliament recently, indicates that copies or generic versions of all products having patent protection in Kenya or else where can be considered "counterfeit" in case of an intellectual property dispute. Since a majority of medicines manufactured by Indian Companies are under Patent protection in some Country or the other (though they do not enjoy patent protection in India or Kenya), the definition, in its current form, can be misused to delay or prevent supply of low – cost generic medicines to Kenya. Africa accounts for 14 percent of India's \$8 – billion medicine exports. Incidentally, a majority of the African Nations and India are on the two sides of the table in the ongoing talks to review the World Health Organisation's definition of "counterfeiting". While India opposes all attempts to link intellectual property issues with "counterfeiting", African nations have a different view.

### **EPB seeks IPR protection for 5 products from Uttar Pradesh**

To counter the threat from International Market to Country's traditional art and craft, the Export Promotion Bureau (EPB) is initiating the process of filing of necessary applications to acquire Intellectual Property Rights (IPR) protection of unique products produced across Uttar Pradesh; through registration under GI.

The bureau along with the Intellectual Property Lab, Lucknow is ready to file the applications for some key products across the State. The five places shortlisted for the GI status are Ferozabad for glass bangles, Moradabad for metal ware, Kanpur for leather saddlery, Kannauj for Attar (perfume) and Bhadohi for carpets. A major bulk of the produce is exported to countries including Australia, USA, England, Denmark and South Africa.
